Privacy Policy

In accordance with the General Data Protection Regulation (GDPR) (EU) 2016/679 and the Greek law No 4624/2019, SANTOXENIA O.E. (we), as a company operating in the Boat Rental, Boat Cruises, and Sailing Industry, collect and use the information (personal data) that you provide us. This privacy policy explains our obligations and your rights in relation to that information (personal data).

A. Data Information We May Collect and For What Reasons:

We collect the following data:

- Full name
- Email address
- Phone number (optional)
- Names and surnames of all passengers
- Optional text message
- Internet Protocol address (IP address)
- Payment details (processed via Stripe)

We do not collect "sensitive information." We do not collect any personal data provided by children under the age of 18 years old.

B. Legal Grounds for Processing Your Personal Data:

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract we are about to enter into or have entered into with you.
- The provision of the services you appoint us for and you wish to receive from us.
- Complying with a statutory obligation, such as returning prepayment, managing your claims, etc.
- Safeguarding and protecting the legitimate interests of yours as well as ours.

C. Share Information - Transfer to Third-Party Associates:

We share your personal data with the following categories of recipients:

- Governmental authorities, law enforcement agencies, etc.
- Our associates (accountants and insurers).
- Stripe for payment processing.

We declare that we do not sell the information you provide us.

We will only keep your personal data for as long as necessary to fulfill the purposes we collected it for, including satisfying any legal, accounting, or reporting requirements.
